What is this product?

Type: Shares of a Sub-Fund of Amundi Alternative Funds PLC, a Public Limited Company.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Sub-Fund is an active UCITS and is not managed in reference to a benchmark.

The Manager, Amundi Asset Management, has appointed Winton Capital Management Limited as Sub-Investment Manager.

The investment objective of the Sub-Fund is to seek capital appreciation over the medium to long term. The Sub-Fund seeks to achieve this objective by pursuing a diversified investment strategy (i) that does not necessarily rely upon favourable conditions in any market, or on market direction and (ii) that trades (on a long and short basis) in a number of different instruments including debt, equity, interest rates and foreign exchange instruments for currency hedging and investment purposes. Financial derivative instruments (listed futures, forwards, over-the-counter contracts and/or options) are used to get exposure to those underlying assets.

Intended Retail Investor: This product is intended for investors, with an average knowledge of and some experience of investing in funds, with the ability to bear losses up to the amount invested.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the Amundi Alternative Funds PLC prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.

The risk indicator assumes you keep the product for 5 years.

What happens if Amundi Asset Management is unable to pay out?

COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years is based on our assessment of the risk and reward characteristics and costs of the Sub-Fund. This product is designed for medium-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.
