The issuer capping for the MSCI ESG Selection P-Series 5% Issuer Capped Indexes has been modified. The weight of issuers in the MSCI ESG Selection P-Series 5% Issuer Capped Indexes is now capped at the maximum of 5% or their weight in the Parent Index (the "**Change**").
